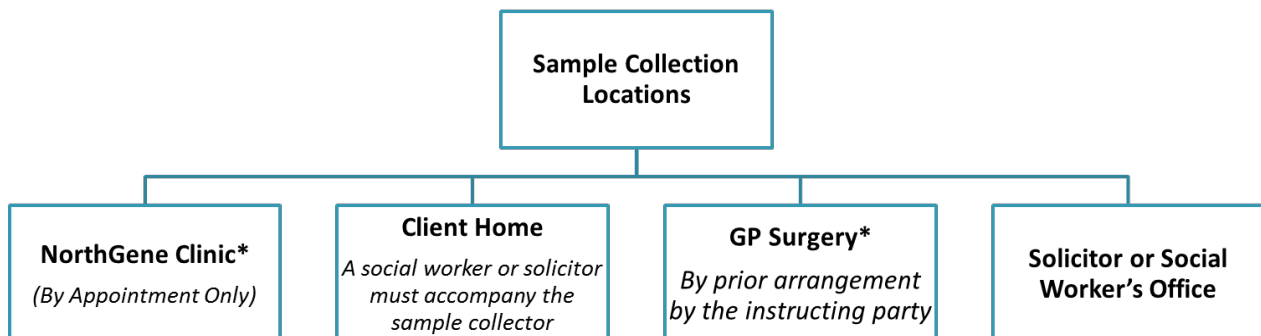
- Approximately 1cm of head hair is required for each month requested.
